### 15/24 Consideration of a response to the Lime Down Solar Park.

Cllr Maltby and Cllr Atkey offered to attend the Wiltshire Council meeting on 21 May. It was decided to send a letter of objection.

#### 16/24 Finance and Administration

a) Schedule of receipts and payments

Receipts of £34,179.04 – Cemetery, precept and the village hall premature payment for the PWLB Loan. Payments of £33,038.86 for staff and admin costs, grass cutting, election fees, premature final payment for the PWLB loan, survey for the Stables. This was proposed by Cllr Slater, seconded by Cllr Anderson and unanimously agreed. All documents were available at the meeting and signed.

b) Update on repairs for the wall of the garden area behind the bus shelter, fencing along the green and the cemetery wall rebuild and path repairs.

The repairs to the wall of the garden behind the bus shelter has been completed ready for planting.

c) Consideration to pledge £20,000 to the community group who wishes to purchase The Stables adjacent to The Hullavington Arms to create a café/pub.

The Chairman gave his summary, copied below.

Great to see so much support for a Community Run Pub and we the parish council members appreciate the hard work and effort the team have put into this in such a short timeframe.

I personally would like to see the Pub retained in the village and I'm sure I speak for all councillors here present.

Please be mindful tonight that the PC members are low level government officers and bound by law and guidance, we cannot act in the same way as groups or individuals. Regardless of any decision made tonight we are volunteers so please be respectful, we serve the interests and views of all parishioners in these matters.

#### Planning Application:

The PC has been supportive of retaining a Pub in the village from the initial planning application and conditions requested in support of opening the pub prior to the sale of the 1st property.

The refreshing of the Asset of Community Value which includes the whole site, paddock car park, the current pub building and the Old Stables.

#### Be aware of the key issues:

There are some key issues that everyone should understand, and I'm sure these will have been identified to you and are considerations for the PC tonight.

- 1, The Planning application is still not decided, there are outstanding noise issues to be resolved with the owners' planners and Wiltshire Council.
- 2, For the old stables to operate as a Pub or Café as far as I am aware, the Shop Licence is still to be changed to a Pub licence.
- 3, The land directly in front of the proposed Café does not belong to the owner and needs to be an integral part of the sale.
- 4, The business plan must be in place and is a key consideration document for the PC and the group submission for grant funding. The PC has not had sight of this, only a very early draft copy.
- 5, The valuation survey that the PC paid for is still to be provided and is necessary to confirm validity of the owner's valuation.
- 6, A written agreement that the owner is willing to sell, subject to successfully Grant Funding application.
- 7, Purchase of the property out a development site with potentially complex planning interdependency and lift and shift right on the parking.
- 8, Complete redevelopment of the property and the pitfalls that that might bring forward additional costs (budget risk).

#### Funding:

There is a risk if not enough funding is available to match fund the 95k, the project may slip and the Grant Funding may not be achieved in year, the team are on a last push to secure funding to complete the Business Case and submit to a tight timeframe, the PC understands that.

The project and financial risks are owned by the team and should be an integral Risk in the Project Risk register and not a risk for the PC to manage, regardless of any decision made tonight.

GJ.S 12/06/2024 The PC has no means to pledge £20k, s137 expenditure is limited to £10.81 per elector, meaning the electorate would have to be 1,851 to be able to meet a 20k bid for in year budgeted funding.

The request is for 20k match funding, and a decision is required tonight.

#### The options:

1. No,

We have no legal means to pledge or pay on request 20k to honour the pledge.

2. Modify the resolution to support a lesser amount will require a proposal to amend the funding request, proposed amount and to be seconded and supported by the majority here tonight.

This would have to be captured in the 25/26 budget round to be ear marked reserves and spent in year in 25/26.

I will await PC member considerations of the two options above.

It was agreed that the Chairman will write a letter of support on behalf of the Parish Council. A structural engineer had visited yesterday (7 May 2024). The Council were informed that the final round for Government funding ends in two weeks. Against the advice of the Clerk, it was proposed by Cllr Anderson, 5 agreed, 1 against to pledge s137 funding up to £9,800 towards this project.
